

Smash Video Contest

1. Eligibility: This Contest is open only to those who sign up at Sin City Smash, Smash Something, 512 Rage Rooms, Smash Therapy, Just One of Those Dayz, Smash the Rage, Break It!, Rage Room Philadelphia, and Relief Room Rage Rooms – Hereby known as RRBO and who are 18 years of age or older as of the date of entry. The Contest is only open to legal residents of the United States of America, and is void where prohibited by law. Employees of RRBO, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of RRBO as final and binding as it relates to the content of this Contest.
3. Contest Period: Entries will be accepted online starting on June 1st 12:00am CST and ending June 30th 11:59pm CST. All online entries must be received by June 30th 11:59pm CST
4. How to Enter: The Contest must be entered by submitting a video through YouTube with the hashtag #smashvideocontest. The Contest video must be filmed at one of the RRBO Locations. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of RRBO. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of RRBO.

5. Prizes: The Winner of the Contest (the "Winner") will receive \$500. The specifics of the prize shall be solely determined by RRBO. 7. Winner Selection and Notification: Winner will be selected by the number of likes their video receives on YouTube under the hashtag #smashvideocontest, under the supervision of RRBO. Winner will be notified by a message through YouTube, Facebook, E-mail, or Instagram within five (5) days following selection of Winner. RRBO shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. In such case, RRBO may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by RRBO. RRBO reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions. RRBO has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same

computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws. Should such attempt be made, RRBO reserves the right to seek damages to the fullest extent permitted by law.
